## The Early Ford V8 Club of America Regional Group 127 United Kingdom Privacy Policy 2019

**Introduction:** This policy sets out how The Early Ford V8 Club of America RG 127 UK (referred to subsequently as the Club") operates in compliance with all current data protection legislation including the General Data Protection Regulation.

**Data collected:** We collect members' names, addresses, email addresses, phone numbers, and club vehicle details - data relating to post in the Members Roster when a member joins the club. We update this information at annual membership renewal. The membership registrar collects and holds the information. We collect images of members, passengers and vehicles in support of club activities.

**Data processors:** These are the Club committee members, the magazine editor, membership registrar, webmaster, events co-ordinators and organizers.

**Data use:** We use the data to enable the Club to pursue its activities, including sending to each member by post - . The four annual Club Magazines . Notices of general meetings . Membership renewal forms.

We use vehicle and ownership history to help members resolve UK vehicle registration matters and authentication. where it is helpful, we supply relevant members details to members who organize tours or other events, or simply wish to access each other. We reproduce photographs submitted by members in the magazine or on the website or social media, and we may store them in the archive. Committee members make limited use of members' data as required for them to perform their roles.

**Data storage and retention:** The membership list is stored in an offline "Word" document accessed only by the membership registrar. Records relating to those who are no longer members are deleted after two years. The deletion of lapsed members and the addition of new members is the sole responsibility of the membership registrar. Paper renewal forms are stored in a file under the care of the registrar. We will only ever use your personal details for club use. .If you give us your personal details - for club use only - over the phone, we will always follow that phone call with email/postal confirmation of your consent. . If you ask to be "forgotten", we will remove all of your personal details within three months. . Access to the membership list is open to all members via a request to the committee, on the understanding that the use of the information given will be restricted to club use only.

**What we don't do with members data:** We do not give or sell data to any other organization, company or club and would not do so without the specific consent of each member concerned. We do not pass a member's information to other individuals if that member has asked us not to do so. We do not store members' credit or debit card details. We do not make members' details visible or accessible on the Club website or social media.

**Consent:** Members are advised on the joining and renewal form that their data, i.e. name, address, email and details of car or cars and any other information relevant to the Club will be stored/ held on manual or electronic recording systems strictly for club use only. Members of the club are given an opportunity on joining and at renewal to limit the information held.

**Subject access:** We will provide to any member who formally asks the secretary the information held about him/her, within one calendar month, free of charge. If a member requests for his/her details to be "forgotten", we will remove all of their personal details within three months.

**Your Rights:** You may ask us not to process your information for marketing purposes.. You are entitled to a copy of the information we hold about you and to ask us to correct any inaccuracies . You may make a complaint to the Information Commissioner.
